### Healthy participants needed for driving simulator study

St. Michael's Hospital and U of T are seeking healthy control subjects to participate in a driving simulator study aimed to understand how disorders of the brain affect driving abilities. You may be eligible if you meet ALL of the following criteria:

- You are between 18 and 85 years of age.
- You have a valid Ontario G class driver's license.
- You have NOT had a history or past diagnosis of a neurological or psychiatric condition.
- You live in Toronto or the GTA.

The study takes place in our research lab for 1-2 hours where you will be required to complete simulated driving scenarios and some additional cognitive tests. Your participation in this study is voluntary and all data will be kept confidential.

You will be compensated for participation if you are eligible. A phone screening (which participants will not be reimbursed for) will be required to determine eligibility. If you are interested, contact:

#### King Lear

Play date: September 24, 2014



King Lear is one of my favourite plays by Shakespeare. It deals with timeless themes surrounding family and loyalty. The king wants to divide his kingdom equally between his three daughters, Goneril, Regan, and Cordelia. They must please the king by verbally professing their love. Cordelia is the youngest and cannot get the words out because her

feelings are so strong. Lear banishes her and divides his kingdom in two between the older daughters, planning to spend equal time at each of their courts. He becomes an encumbrance to them, and they shun him. He ends up insane on a heath in a storm, accompanied only by his Fool and Edgar, the son of one of his closest friends. The Fool, of course, is one of the smartest people in the play.

This is a tragedy, and a powerful one. I've seen it played by John Colicos many years ago and Peter Ustinov (not very well), and it is a compelling story. It is usually, as Prospero in The Tempest, played by an actor later in his career. Colm Feore is in his mid-fifties and I look forward to an energetic interpretation of the character. The Fool will be played by Stephen Ouimette, and Gloucester by Scott Wentworth, whom we admired so much in Fiddler on the Roof and Merchant of Venice in 2013.
